

Workday to Transfer Stock Listing to NASDAQ

Workday shares are expected to begin trading as a NASDAQ-listed security at market open on Sept. 20, 2017, with the common stock continuing to trade under the symbol "WDAY." This transfer is expected to be seamless for Workday investors and shareholders.
